## CONTRIBUTION OF HON'BLE SHRI SHARAD PAWAR

Hon'ble Shri Sharad Pawar was elected as the President in the year 2001. Hon'ble Shri Sharad Pawar put forth a development plan for the Association and he wanted to create infrastructure facilities and also strengthen the finances so that the Mumbai Cricket Association would be number one amongst the members of the BCCI. He set targets for the development of the Association and while doing so he wanted to create facilities closer to the residence of the junior cricketers so that they would not have to travel long distances.

The members of the Mumbai Cricket Association unanimously decided to amend the constitution of the Association to ensure that Hon'ble Shri Sharad Pawar continues as the President beyond the term of eight years. He continued as the President of the Association from 2001 to 2011 and again got elected as the President of the Mumbai Cricket Association in the Biennial Election held in 2013 and was re-elected in 2015.

1. In 2002, Hon'ble Shri Sharad Pawar succeeded in getting the allotment of 13 acres plot of land at the Bandra Kurla Complex for development of Indoor Cricket Academy and other related recreational facilities.
2. In 2006, Hon'ble Shri Sharad Pawar undertook the work of Cricket Centre Building which houses the offices of Mumbai Cricket Association and BCCI.



3. In 2009, the Association undertook the refurbishment of Wankhede Stadium to conduct the ICC World Cup 2011 matches. But for the personal intervention of Hon'ble Shri Sharad Pawar, It would not have been possible to complete the redevelopment work within 2 years with all the compliance and permissions from the authorities. The Wankhede Stadium successfully hosted the final match of ICC World Cup 2011 which India won.
4. Hon'ble Shri Sharad Pawar identified another plot of land at Kandivali to facilitate the suburban cricketers and the same was allotted to Mumbai Cricket Association by the MCGM in the year 2008 for a period of 10 years thereafter renewable every 10 years. The said facility has been named after the cricketing icon as Sachin Tendulkar Gymkhana.
5. As soon as Hon'ble Shri Sharad Pawar took over as the President of the Association, he segregated General Administration and management of cricketing activities. He appointed the Cricket Improvement Committee (C.I.C.) with eminent cricketers like Shri Madhav Apte, Shri Sunil Gavaskar, Shri Dilip Vengsarkar, Shri Ajit Wadekar, Shri Nari Contractor, Shri Ajit Agarkar, etc. and the Managing Committee of the Association has empowered the said committee to independently monitor the cricketing activities and appointment of coaches, selectors and other support staff.



### **IMPORTANT EVENTS OF THE ASSOCIATION**

1. The Association successfully hosted the IPL 2015 matches at Wankhede Stadium.
2. The Association hosted a function for MCA panel umpires on 24<sup>th</sup> March 2015.
3. The Association successfully hosted the 5<sup>th</sup> ODI match between India and South Africa on 25<sup>th</sup> October 2015.
4. The Association felicitated Mr. Zaheer Khan on his glorious contribution to Mumbai and Indian cricket in a career spanning more than 2 decades.
5. The Association presented a cheque of Rs. 1 crore to the Hon'ble Chief Minister of Maharashtra, Shri Devendra Fadnavis towards Chief Minister Relief Fund (Drought Relief)
6. The Association launched the MCA IDBI Bowling Foundation.

## **IMPORTANT DECISIONS OF THE MANAGING COMMITTEE**

1. The Cricket Improvement Committee has been constituted as an independent body to look after cricketing decisions.
2. The Committee reverted back to the original format of the Dr. H. D. Kanga League and other local tournaments.
3. The Committee also approved the installation of flood lights at MCA Sharad Pawar Indoor Cricket Academy Ground at BKC.
4. The Indoor Cricket Facility at BKC is now available to affiliated clubs and corporates after 5.30 pm depending on the availability. The charges for the same are as under:
  - a. For Affiliated Clubs : Rs. 10,000 per hour per net
  - b. For Corporates : Rs. 15,000 per hour per net
  - c. For Corporates : Rs. 50,000 for 2 hours all nets
5. It was decided to lift the ban on Mr. Shahrukh Khan and he be allowed to enter into the Wankhede Stadium henceforth.
6. The Association donated Rs. 1 crores to the Hon'ble Chief Minister, Shri Devendra Fadnavis towards Chief Minister's Relief Fund (Drought Relief).
7. Mumbai Senior Women's team was sent to Tanzania to participate in the Azam Women Cup as a preparation for the BCCI matches.





## **REPORT OF REGISTRATION OF PLAYERS SUB-COMMITTEE**

There have been some modifications in the registration of player's rule as follows:

- 1) The earlier Registration process where the Secretary of the club had to certify the documents of the players has been discontinued and the players are made responsible for the authentication of their documents and the documents should be self-attested, hence the onus is on players to certify the authenticity of the documents.
- 2) The process of MCA registration of school boys for participation in the U-16 Harris Shield, U-14 Giles Shield, U-14 Ghantali Cricket Tournament and U-16 Bhandari Cricket Tournament is made compulsory.
- 3) U-16 players who have played Dr. H.D. Kanga Plate League 2014-15 are eligible to play in 'A to D' Division of Dr. H.D. Kanga League 2015-16 with proper registration (club addition) or special permission. The eligibility for U-16 Players is born on or after 01.09.1999.

### **FROM THE DESK OF THE TREASURER**

I take pleasure to present before you the audited financial report comprising Balance Sheet as at 31st March 2015 and the Income and Expenditure for the year 2014-15 together with schedules and notes to accounts. The annual accounts for this year are being presented within period of 11 months after presenting the audited accounts for the previous year.

The year gone by had witnessed certain events briefly listed below,

1. The Association successfully conducted Dr. Kanga League tournament (both Plate and Elite Group) in restructured format as in the last year.
2. Prizes and awards for the season of 2013-14 were distributed during a function held in November 2014.
3. Junior Cricketer's (under-19) team of the Association won the championship trophy under Cooch-Bihar Tournament.
4. Junior Team of Under - 14 players were Finalist at West Zone level comprising 5 Associations (Mumbai, Pune, Baroda, Gujarat and Saurashtra).

As regards the financial position, salient features are as under :

- ❑ The financial year 2014-15 has ended with surplus of Rs. 6.25 Cr. after depreciation of Rs. 30.96 Cr. and provision for contingencies of Rs. 31 Cr.
- ❑ The "Other income" is higher by Rs. 52.26 Cr This was mainly due to income from variable licence fee received for 2 years for MCA recreation centre operated by M/s Shirke Infrastructure.
- ❑ The Association did not have international match at Wankhade Stadium during the year.
- ❑ There were only 5 matches under IPL tournament in May 2014.
- ❑ The subsidy income from BCCI has come down from Rs. 35.14 Cr. in 2013-14 to Rs. 21.33 Cr.

Let us have a look to the financial health in terms of assets and liabilities.

The salient features are briefly as under ;

- ❖ The fixed assets after depreciation now stand at Rs. 254.48 Cr.



- ❖ The current assets are higher by Rs. 55.55 Cr. mainly due to increase in receivable from Shirke Infrastructure (Rs. 25.40 Cr), BCCI (by Rs. 8.17 Cr). Income Tax paid under protest (Rs. 17.35 Cr) and tax deducted at source (by Rs. 4.33 Cr).
- ❖ The liabilities are more by Rs. 17.72 Cr. This is mainly on account of provision for contingencies of Rs. 31 Cr. and reduction in liability of Rs. 7 Cr. of Shirke Infrastructure now taken to income, AC box advance income Rs. 7.75 Cr appropriated as income.
- ❖ The net worth is finally higher by Rs. 11.30 Cr and stood at Rs. 276.74 Cr as on the end of March 2015.

Despite having credit of Tax deducted at source of Rs. 16.90 Cr, and payment of tax of Rs. 17.24 Cr up to last year, the Association was compelled to pay further amount of income tax of Rs. 17.35 Cr. during the year. In all the total tax to the credit of Association now stands at Rs. 51.50 Cr. Balance income tax demand till Assessment year 2013-14 stood at Rs. 4.51 Cr.

I express my sincere thanks to the office bearers and members of the managing committee, the members of MCA, and staff members for their support and co-operation.

## AUDITORS' REPORT

### INDEPENDENT AUDITORS' REPORT TO THE MEMBERS OF MUMBAI CRICKET ASSOCIATION

#### Report on the Financial Statements

We have audited the accompanying financial statements of **MUMBAI CRICKET ASSOCIATION** ("the Association") which comprise the Balance Sheet as at 31<sup>st</sup> March, 2015, the Income and Expenditure Account for the year then ended, and a summary of the significant accounting policies and other explanatory information.

#### Management's Responsibility for the Financial Statements

The Association's Management is responsible for the preparation of these financial statements that give a true and fair view of the financial position and financial performance of the Association in accordance with the Accounting Standards and in accordance with the accounting principles generally accepted in India. This responsibility includes the design, implementation and maintenance of internal control relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

#### Auditors' Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with the Standards on Auditing issued by the Institute of Chartered Accountants of India. Those Standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and the disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the Association's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Association's internal controls. An audit also includes evaluating the appropriateness of the accounting policies used and the reasonableness of the accounting estimates made by the Management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

#### Basis for Qualified Opinion

1. Certain matters which were reported in the audit report of the previous year, and which continue to remain unresolved as at 31<sup>st</sup> March, 2015 are summarised as under:
  - 1) Attention is invited to Note 3 (A) of the schedule 19 to the financial statement, as per the terms of MOU, Association is entitled to receive compensation in respect of the incremental area which may be built up by GCH. The MOU also provides that the cost of construction is in the first instance to be paid and borne by GCH and subsequently GCH shall adjust the compensation due to the Association against such costs. However, in absence of complete details regarding cost incurred by GCH, the Association has neither recognised the increase in area or value of the Asset nor has recognized any income in respect of compensation so adjusted by GCH.
  - 2) Attention is invited to Note 4 of Schedule 19 to the financial statements, regarding a contract entered into with Shirke Infrastructure ('Contractor') to develop Indoor Cricket Academy ('ICA') and related facilities ('ICA Facilities'), the entire sums received under the contract as well as the capitalized amount of ICA and ICA Facilities are credited to corpus of the Association. The Association has taken a view that the same is eligible for income tax exemption and no provision for tax is required.



- 3) Attention is invited to Note 8© of Schedule 19 to the financial statements, regarding the non-provision of the tax on account of withdrawal of registration under section 12(A) by the tax authorities, which is based on legal opinion obtained by the Association. The Association during the year has created an adhoc provision for above contingency amounting to Rs.31,00,00,000.

**Qualified Opinion**

In our opinion and to the best of our information and according to the explanations given to us, except for the effects of the matter described in the Basis for Qualified Opinion paragraph above, the aforesaid financial statements give a true and fair view in conformity with the accounting principles generally accepted in India:

- (a) in the case of the Balance Sheet, of the state of affairs of the Association as at 31<sup>st</sup> March, 2015;
- (b) in the case of the Income and Expenditure Account, of the surplus of the Association for the year ended on that date.

**Emphasis of Matter**

Attention is invited to Note 6 of Schedule 19 to the financial statements, regarding allotment of Air-conditioned boxes, the Association is of the view that there are no other indirect taxes applicable on the transactions, other than Entertainment Tax.

Our opinion is not qualified in respect of this matter.

**SCHEDULE 19****NOTES FORMING PART OF ACCOUNTS FOR THE YEAR ENDED 31<sup>ST</sup> MARCH, 2015**

- 1.. The MUMBAI CRICKET ASSOCIATION (the "Association") is registered under Societies Registration Act, 1860 and Bombay Public Trust Act, 1950 under Reg.No. Bom/300/74 GBBSD dated 21st October, 1974 and No. F 3451- (Mum) dated 30th November, 1974 respectively.

The Association is an affiliated unit and a permanent member of Board of Control for Cricket in India ("BCCI").

**2. Significant Accounting Policies:****A. Accounting Convention:**

The financial statements have been prepared under the historical cost convention following the accrual concept of accounting in accordance with generally accepted accounting principles in India.

**B. Revenue Recognition:****i. International match**

Income from International Match represents revenue from sale of entry tickets (including entertainment tax), income from renting space for advertisement, rent from caterers for snacks stalls during match less expenses incurred for hosting such match, Financial Assistance to member clubs, contribution to Benevolent Fund, Umpires Benevolent Fund, Maidan Improvement and Development Fund under the rules and regulations framed by the Association from time to time.

**ii. Domestic matches**

Income from Domestic matches represents revenue from sale of entry tickets, sponsorship amounts and subsidy from BCCI less expense incurred for such matches.

**iii. Match Telecast, Hosting Fees**

The income from match telecast and hosting fees from BCCI is recognized in the year in which certain conditions as laid down by BCCI are fulfilled.

**iv. Income from Property**

Rental income from offices in North stand, compensation for the premises covered under catering services, Ground Hire charges, and Dressing Room hire charges is recognized on accrual basis except for the item referred to in note no. 3(A).

Income from lease rent of part of Cricket Centre is recognized equally over the contract period and appropriated out of Advance Lease Rent.



Income from Variable License Fees in respect of MCA Recreation Centre at BandraKurla Complex is recognised as per the terms of agreement, on the basis of duly certified details received.

Income from use of facilities at Bandra Kurla Complex by BCCI as Specialist Batting Academy is recognized on yearly basis as per the terms of agreement.

**v. Sponsorship Amount**

This is recognized on the basis of terms of agreement between the Association and sponsor.

**vi. Income from Air conditioned (AC) Boxes**

Income from Air conditioned Boxes is recognized as per the terms of agreements/allotment letters with the allottees on pro-rata basis.

**vii. Other Income**

Registration, renewal and transfer charges from players, donations, and other miscellaneous income are recognized on receipt basis.

All items of income are recognized gross of income tax deducted at source wherever deducted.

**C. Corpus (Trust fund)**

Additions to Corpus including Entrance fees are accounted on receipt basis.

**D. Transfers from Earmarked funds**

The amounts transferred from the earmarked funds for incurring expenditure are shown to the credit of Income and Expenditure Account and the payments made against those funds are shown as 'Expenditure on the sport activities'.

**E. Fixed Assets and Depreciation**

Fixed Assets are stated at cost less accumulated depreciation. Depreciation is calculated as per written down value method at rates prescribed in the Income Tax Act, 1961.

The Leased Assets are amortized over their economic useful life.

The period of lease pertaining to plot of land on which Wankhede Stadium is constructed, expires in February 2018 and for which the management is confident of its renewal.

**3. Garware Club House (GCH):**

- (A) The Association has entered into a Memorandum of Understanding ('MOU') with GCH on 6th March, 2005. As per the terms of MOU, Association is entitled to receive compensation in respect of the incremental area which may be built up by GCH. GCH has adjusted the said sum payable to the Association against the cost of construction





which as per the MOU is in the first instance paid and borne by GCH. However, in absence of complete details regarding cost incurred by GCH, the Association has neither recognised the increase in area or value of the Asset nor has recognized any income in respect of compensation so adjusted by GCH. On the amount of compensation so adjusted, GCH has also deducted and paid TDS of Rs. 8,13,888 to the credit of Association. The Association, is of the view that only the amount of TDS paid by GCH to the Income Tax Department amounts to a constructive receipt of such amount, and has accordingly recognized Rs. 8,13,888 as income under the head "Other Income".

**(B) Stand Reservation Charges:**

As per the terms of the above referred MOU with GCH, status quo is maintained in respect of Stand Reservation charges of Rs.1,20,00,000 collected prior to the existence of Garware Club House. The Association continues to appropriate annual amount of Rs. 3,00,000 to the Income and Expenditure Account over the lease period, which expires in February 2018.

**4. Indoor Cricket Academy and MCA Recreation Centre, Bandra-Kurla Complex**

- (A) The Association had entered into a contract dated 12th December 2005, with Shirke Infrastructure for development of the Indoor Cricket Academy (the 'ICA') and the ICA facilities. As per the terms of the said contract, the developer is to pay Rs.75,00,00,000 towards the Corpus of the Association over the contract period of 17 years and Rs.5,00,00,000 as deposit for the maintenance of ICA, refundable only on completion of the contract period. Accordingly, till March 2015 the Association has received an aggregate sum of Rs.65,00,00,000 towards corpus, including Rs.5,00,00,000 received during FY 2014-15 which has been added to Trust Fund. The interest income from the non-refundable deposit of Rs.5,00,00,000 and the deposit are treated as Earmarked fund and is utilized for the running and maintenance of the Indoor Cricket Academy. As per the terms of the agreement the entire interest accrued on the Deposit amount is reflected as income of the Association under the head Other Income- Interest (Schedule 12).
- (B) As per the agreement entered with Shirke Infrastructure, last installment of negative grant of Rs.5,00,00,000 has been kept as deposit in joint names of the Association in Karnataka Bank, Pune. The said fixed deposit has been reflected in the Balance Sheet under Current Assets, Advances and Deposits and corresponding contra entry of Rs.5,00,00,000 has been made under Current Liabilities, Provisions and Loans.
- (C) During the year ended 31st March 2009, the Indoor Cricket Academy and the respective assets therein were capitalized for Rs.18,80,03,000 based on the best estimate of M/s R. C. Jain & Co Chartered Accountant and credited to Corpus. W.D.V. in books in respect of these items stood at Rs.16,60,47,950 as at 31st March 2010. Subsequently, the Association got the valuation done from approved Government valuer who valued the same at Rs.17,91,26,923 as at 7th August 2010. However, on a conservative basis the assets are continued to be recognised as per the valuation adopted in the past.



(D) As per the Supplementary agreement dated 7th November, 2014 Association has recognized a variable license fees, in respect of MCA Recreation Facilities, amounting to Rs. 50,44,09,425 (Rs. 25,75,22,698 of F.Y. 2013-14 and Rs. 24,68,86,727 of F. Y. 2014-15) based on the duly certified data received from auditors of M/s. Shirke Infrastructures.

5. The Association has got constructed(at no cost to Association) the Sports and Recreation Centre at Kandivali as per terms stipulated by Municipal Corporation of Greater Mumbai (MCGM). The Activities of this Sachin Tendulkar Gymkhana have commenced and nominee members of the affiliate clubs are using the said Gymkhana facilities. In accordance with the conditions prescribed by MCGM, entire infrastructure has been constructively handed over to MCGM on 8th January 2014.
6. The Association has entered into agreements with various companies/firms for allotment of AC boxes in the newly developed Wankhede Stadium for viewing the Cricket Matches over the period from 1st March 2011 to 28th February 2021.

The Association has received amount of Rs.17,95,62,500 towards interest free deposits and recognized amount of Rs.46,29,79,167 as income received in advance as at 31st March, 2015 from the allottees of AC boxes.

The Association has already deposited Entertainment Tax on the income from these boxes as per the instructions received from the concerned Department of Maharashtra Government and consequently the Association is of the view that there are no other indirect taxes payable on the above transaction.

#### **7. Group Gratuity Scheme with LIC:**

The Association has a gratuity scheme for its staff with the Life Insurance Corporation of India ('LIC'). The premium paid to LIC is being recognized as expenditure in the Income and Expenditure Account. During the year amount of Rs.18,11,916 has been paid to LIC.

#### **8. Tax and other Legal matters:**

##### **a. Contribution payable to Public Trust Administration Fund at Charity Commissioner's office:**

During the year, the Association has provided Rs. 1,76,90,000 for the contribution payable to the office of Charity Commissioner of Mumbai Region. Payment has however not been effected in light of the decision of the Bombay High Court.

##### **b. Property Tax:**

The Association has made provision for property tax in respect of all properties based on the Property Tax bills received from MCGM. The provision for outstanding liability aggregating to Rs. 4,09,75,298 as on 31st March 2015 has been made although the Association has disputed the tax demanded in some cases.



A refund of property tax of Rs. 66,17,770 granted and adjusted against property tax demand in the bills by MCGM has been recognized as income and is treated as “property tax paid” by MCA.

As regards other refunds determined by Property Tax Department of MCGM for past period in case of some properties, the same will be recognized on receipt from MCGM.

**c. Status of Income Tax liability:**

- 1) ITAT has cancelled the registration of the Association under section 12 A w.e.f. June 1, 2010 (date from which the power for cancellation of registration u/s 12A was granted by an amendment in the IT Act). The Association has appealed before the Honorable Bombay High Court against the decision of Income Tax Appellate Tribunal (ITAT).

Arising out of the said legal issues in dispute; an aggregate Income Tax Demand of Rs. 5436.62 Lakhs has been raised for the years AY 2006-07 to AY 12-13 [excluding AY 2009-10 where there is NIL demand as the CIT (Appeals) has upheld the claim of the Association]. The Association has paid a sum of Rs. 32,09,03,959 under protest and after considering TDS credits granted, the balance demand outstanding as per last intimation by the Income Tax Department on 3rd June 2015 is Rs. 451.32 Lakhs.

Though the Association continues to dispute the above demands raised by the Income Tax Department, the Association during the year has created an ad hoc provision for contingency of Rs. 31,00,00,000 in relation to the above, as disclosed under schedule 14 (Expenditure on Administration) in Income & Expenditure Account and under Schedule 3 (Current Liabilities, Provisions & Advances).

- 2) The IT return for A.Y.2014-15 is yet to be filed.

**d. Service Tax Proceedings:**

The Association had received “Show Cause” notice from the Service Tax authority for the following:

- a) Event Management – This includes service tax on various payments made to MCA by BCCI like (i) reimbursement of match expenses (ii) Match subsidies (iii) IPL subsidy and TV subsidy (iv) Prize Money etc. amounting to Rs. 30,11,07,385.
- b) Mandap Keeper- This includes service tax on amounts collected from allottees of various AC Boxes including Donor Boxes- Rs. 9,48,06,350.



- c) Renting of Immovable property- This includes service tax on lease rent of 4th Floor of the "Cricket Centre" paid by BCCI to MCA- Rs. 1,54,50,000.

Out of the above, the service tax on renting of 4th floor of "Cricket Centre" was paid during the F.Y. 2013-14. Other matters still been under adjudication, the Association is of the view that the same are not payable and hence, no provision has been made in respect of the same.

**e. Rent Income from Office Premises and Tenants' Matter :**

On completion of redevelopment of Wankhede Stadium, tenants were handed over possession of their respective premises. Subsequently, the Association filed suits for eviction and fixing Standard Rent with Small Cause Court, Mumbai.

Pending the outcome of the legal cases, no income from renting of above said properties have been recognized during the year. Income will be recognized on the outcome of legal matters.

**f. Selvel Matter:**

Association's claim against M/s Selvel towards loss due to Selvel backing out from tendered amount for advertisement during the test match played between India and West Indies in November 1994 was allowed by Honorable Bombay High Court. M/S Selvel has deposited Rs.43,22,922 in Canara Bank as ordered by the Court. The amount will be recognized as income after final outcome of the Appeal filed by M/s Selvel.

**9. Contingent Liabilities:**

As explained in Note no.8(c) above, total demand (net of provision for contingency) of Rs. 2336.62 Lakhs is treated as contingent liability.

10. In the opinion of Management, the provisions are adequately made towards amounts due but not paid as on 31st March, 2015.

**11. Additions to Corpus**

Entrance Fees received from Associates in regard to admission to the Facilities at BKC and Kandivali (Rs.1,60,000/- and Rs.20,000/- respectively) have been credited to the Trust Fund.

12. Previous year figures have been regrouped and rearranged wherever considered necessary.
